

**विषय:- Onboarding ESIC on Jeevan Pramaan Portal for Digital Life Certificate-reg.**

As per directions from the Ministry of Labour and Employment and w.r.t. the proposed implementation of Jeevan Pramaan in ESIC, following steps have been taken:

1. Jeevan Pramaan Project, NIC, New Delhi has been requested (Copy enclosed) to onboard ESIC on the Jeevan Pramaan Web Portal of Government of India, so that the facility of generating of Digital Life Certificates can be availed of by the pensioners and family pensioners of ESIC.
2. In the first phase of implementation of Jeevan Pramaan in ESIC, SBI (as disburser of pension) has been asked (copy enclosed) to honour Digital Life Certificate generated on Jeevan Pramaan Portal in respect of ESIC pensioners and family pensioners for disbursing their pension.
3. In the second phase of implementation of Jeevan Pramaan in ESIC, the ERP system will be functional for those pensioners and family pensioners whose pension is being disbursed from ESIC RO/SRO/Hospital (after Aadhaar seeding/verification provisions are implemented in ESIC with the permission of the concerned authorities and through Aadhaar Vault Solutions).


