The promotion of the officials appeared at s.no. 2 & 3 will take effect from the date of assumption of charge to the promotional post at their existing place of posting and promotion of the officials appeared at 1 shall take effect from the date of declaration of result of LDCE i.e. 25.11.2021 at their existing place of posting as they are already officiating as Adhoc LDC.


On their promotion to Lower Division Clerk on regular basis, they will draw their pay in the revised pay level- 2 of revised pay structure as per 7th CPC recommendations corresponding to the pre-revised pay band of Rs. 5200-20200 with Grade Pay of Rs. 1900/- or the existing pay, whichever is higher pending fixation of pay under the rules. **They may also opt for the fixation of their pay, under rule FR 22(I)(a)(i) regulated by the provisions of Rule 13 of CCS (RP) Rules, 2016, within one month from the date of issue of this order.**

However, officials getting above mentioned pay scale or higher pay as financial up-gradation under ACP/MACP Scheme shall continue in the same pay scale and no pay fixation in their case in the promoted post's pay scale is required.

The promotion of officials is subject to such terms & conditions of services as are applicable to similar class of employees as laid down in the Employees' State Insurance Corporation (Staff & Condition of services) Regulations, 1959 as amended from time to time.

**Seniority of the officials will be fixed in the respective vacancy year in which they have selected as mentioned against their name.**
