### CIRCULAR

**Sub:** Prohibition of Private Practice by Medical Officers -reg.

It is hereby brought to the notice of all Medical Officers (Teaching Faculty, Specialists, GDMOs, and Senior Residents) posted at ESIC MC, PGIMSR & Model Hospital, Rajajinagar, that engagement in any form of private practice is strictly prohibited as per Rule 15 of the CCS (Conduct) Rules, 1964, which is explicitly states that no government servant shall, except with the prior sanction of the government, "engage directly or indirectly in any trade or business, or undertake any other employment".

In this regard, all Medical Officers are hereby instructed not to engage in any form of private practice, directly or indirectly, under any circumstances.

Any deviation or violation of the above instructions will be viewed seriously, and strict disciplinary action will be initiated against the concerned Medical Officers as per the rules without any further notice. Heads of Departments are requested to bring this circular to the notice of all Medical Officers working under their control and ensure strict compliance.

This circular may be treated for strict compliance.
