**Sub:- Intimation regarding Blacklisting of M/s. Gajanana Enterprises, contractual outsourcing  
Paramedical agency-reg.**

It is to inform that M/s. Gajanana Enterprises, a Paramedical/Nursing Manpower supply agency was engaged in ESIC MC& H, Kalaburagi since 01.05.2022 to 30.04.2023 through tender on GeM Portal. The agency neither submitted the Performance Security deposit nor executed the agreement during the contract. The agency did not comply to the instructions of this office for the engagement of manpower following reservation roster.

Further, it is to inform that the agency has submitted forged copies of GST Challans since the inception of the contract till the end of the contract, for an amount of Rs.26,67,562.02/-(Rupees Twenty-Six Lakhs Sixty-Seven Thousand Five Hundred and Sixty-Two Rupees and Two Paise Only) and also, the payment of wages and statutory dues were not done by the agency as per GeM Terms and Conditions. It clearly states the violation of the GeM Contract; as a result, it is requested to Blacklist M/s. Gajanana Enterprises, for the period of 03 years from 01.05.2023, to 30.04.2026, to participate in tenders issued by any ESIC Institutions.
