

### OFFICE MEMORANDUM

Sub: Appointment of Private Registered Medical Practitioner as Authorized Medical Attendants (AMAs) under CS (MA) Rules, 1944 for the year 2022-23-reg.

In terms of instructions, contained in Ministry of Health & Family Welfare O.M. No. 14025/113/79-MS dated 28.5.1981 detailed vide Govt. of India decision No. below rule B Central Services (MA) Rules 1944 with the approval of Vice-Chairman, Central Government Employees Welfare Co-ordination Committee, NH-IV, Faridabad, Haryana, 24 Private Registered Medical Practitioners as per enclosed list (Annexure A) are hereby appointed as AMA for the period of one year (i.e. 1<sup>st</sup> April 2022 to 31<sup>st</sup> March, 2023) for providing medical treatment to the employees of Central Government and their family members residing at Ballabhgarh, Faridabad, Palwal, Gurgaon, Bahadurgarh, Patudi etc. and other nearby localities subject to the following terms and conditions.


1. The appointment of AMAs is valid for one year and automatically stands expired on 31.3.2023 at midnight. It can, however, be renewed on fresh application by the Doctors in Month of February, 2023.
2. The treatment at the consulting room of AMA is limited to 10 days with a maximum of four consultations and normally ten injections. The number of injections may go up to 15 depending on patient's ailment.
3. The limit of 10 day's treatment at the consulting room of AMA may be increased to 40 days if the treatment is had in Indian System of Medicines and in Homoeopathy. The total number of consultations will, however, remain 04 at an interval of 10 days.
4. The limit of 04 consultations within 10 days is applicable for attendance with a specialist/ other Medical Officer and will count from the date from which is specialist/ other Medical Officer, is consulted.
5. Cases of Medical treatment requiring hospitalization have to be referred to Government/ recognized hospital.
6. If hospitalization is not considered necessary, but treatment is expected to be prolonged requiring more than 04 consultations or more than a course of 15 injections, as the case may be, either separately or concurrently, the patient should be referred to out-patient department of Government/ recognized hospital.



7. When a patient consults the same AMA in regard to the super-imposition of another disease during the course of treatment of one disease, it is regarded as a fresh consultation and charged for a full rates.
8. Every consultation after the first for the same illness of the same patient with the same AMA is treated as subsequent consultation and charged for at the prescribed on the consultation.
9. Consultation on the 10<sup>th</sup> day of treatment is permissible, if no medicine is prescribed on the consultation
10. If at the time of consultation, the Medical Officer consultant also administers injections, he will be entitled to charge fees both for the consultation and for the injection at the prescribed rates. However, if at a later stage the Medical Officer administers injections prescribed at the previous consultation, fees should be charged for injection only.
11. Utmost economy may be exercised in prescribing medicines where cheaper medicine equal/ therapeutic values are available only those should be prescribed. AMA should indicate their Registration Number while signing bills. Tests/ Examinations etc. should be carried out only a Government recognized Hospitals at the prescribed rates.
12. Indulgence in to malpractices and non-observation of Rules/ Orders lead termination of his appointment as AMA, forthwith besides other statutory actions.
13. The AMAs are further requested to follow the rules and orders strictly issued under CS (MA) Rules.
14. The CGEWCC reserves the Right to terminate the appointment if the services of AMA are no longer required or other-wise without assigning any reasons of giving notice.
15. At present consultation/ visiting / injection fees are as under:-
