2. Reservation will be as per Government of India guidelines issued from time to time.
3. **As per the FAQs issued by the DoPT under file No. 43011/11/2022 - Estt. (Res-II) dated 19.02.2022, if any vacancy earmarked for EWS cannot be filled in a given recruitment year due to the non-availability of a suitable candidate belonging to the EWS category, such vacancies will not be carried forward as a backlog to the next recruitment year.**
4. In case of non-availability of reserved category candidates in the advertised post, the vacancy may be filled up for less than 45 Days as de-reserved seats(s).
5. All Candidates must have up-dated Medical Registration (NMC/ State Medical Council) with all post MBBS/ MD/ MS Qualification(s)).
